To the Honorable, the Senate:

I have approved Senate Bill 601 as 1987 Wisconsin Act 422 and deposited it in the office of the Secretary of State. I have exercised the partial veto in several instances.

Senate Bill 601 provides a one-time only Farmers' Drought Property Tax Credit for Taxable Year 1988. This refundable Drought Credit will pay 10% of the taxes on a farm, with a maximum credit of \$1,000, for farms that meet certain minimum acreage and product requirements. The legislation specifies that the Drought Credits are to be paid only if 40% of the crops in the state are certified as lost. The total cost of the Drought Credit is estimated by the Legislative Fiscal Bureau as \$21.4 million GPR.

I have signed this bill into law because of the unprecedented farm crisis which Wisconsin is now experiencing due to the persistent drought. I would prefer that Senate Bill 601 were more targeted to provide greater assistance to those farmers most adversely affected by the drought. I also felt some reluctance to sign this bill because of its potential effect on the general fund balance, which may now be drawn down periously close to the statutory minimum.

Despite these concerns, I have accepted this Drought Credit only because it is not permanent but is a one-time only credit designed to respond to an extraordinary situation. Ongoing property tax relief for farmers is needed, but it should be provided in the context of general tax relief for all taxpayers.

I have exercised the partial veto to correct some of the technical problems presented by this bill as passed by the Legislature. Senate Bill 601 allows farmers up to a year to claim the Drought Credit after the end of their 1988 taxable year, but it sunsets the credit prematurely on July 1, 1989. I have vetoed sections 3, 5, and 6 of Senate Bill 601, which contain the repeal of sections 71.09(12fd) and 71.65(1)(L) and (2)(g) of the statutes as created by this bill, to resolve this problem. This veto will give farmers the full year to enter their claims and will resolve any problems about the Department of Revenue's authority to pay out credits after July 1, 1989.

I have also vetoed the requirement that property taxes be paid before a farmer claims the Drought Credit. Many farmers will not pay their second property tax installment until next July but will file their income tax forms earlier. I have vetoed section 2 of Senate Bill 601

to eliminate the word 'paid' in section 71.09(12fd) of the statutes establishing the Drought Credit. The effect of this veto is to allow farmers to file for the Drought Credit on the basis of property taxes accrued and to file their Drought Credit claims with their income tax and Farmland Preservation Credit claim forms. This veto will make filing for the Drought Credit easier for farmers, reduce the Department of Revenue's administrative costs, and send money to farmers when they most need it to meet their spring planting costs.

While the intention of the Legislature is that only farms which meet certain acreage and product requirements are eligible for the Drought Credit, the bill contains only a definition of 'farmland,' not a definition of 'farm.' I have therefore used the partial veto four times in section 2 of Senate Bill 601 to create the needed definition of 'farm' by striking out the letters 'land' in 'farmland.' My use of the letter veto was necessary to make this bill a workable piece of legislation.
