We have completed an audit of the Capital Improvement Fund and of the Bond Security and Redemption Fund for the 1987 calendar year, as required by s. 18.10(3), Wis. Stats. Our audit also included a determination of the State's aggregate net indebtedness on December 31, 1987, as required by s. 18.05(3), Wis. Stats.

We found that the State's net indebtedness on December 31, 1987, of \$2.35 billion and the debt contracted during the year of \$277.2 million were within the State's constitutional debt limitations. In addition, our audit did not disclose any transactions which were improper or which materially misstated state records.

We appreciate the courtesy and cooperation extended to us by the staff of the Department of Administration.

To the Honorable the Legislature

I am pleased to submit the attached report "Year One of WEJT: Evaluation of the First Year of the Wisconsin Work Experience and Job Training Program." This submission is being made pursuant to s. 49.50(7j)(g) of 1985 Wisconsin Act 285.

The WEJT program represents a long-term investment in the employability of Aid to Families with Dependent Children recipients. It represents a shift from reliance on welfare payments to employment programs and opportunities, supported by education, training and child care. As such, it is a key component of the State's welfare reform initiative.

I believe this report demonstrates that the WEJT program is beginning to work. While there has been a moderate increase in costs as welfare recipients are channelled into education and training programs, these costs already appear to be declining as recipients become employed. There is every reason to believe that program savings will eventually surpass costs. Also, preliminary indicators are that WEJT program participants are getting better jobs, with higher wages, more hours and better fringe benefits, than those who did not get WEJT services. For example, after six months of employment WEJT participants are making about \$180 per month more than those persons who only participated in job search activities.

Any major and fundamentally new undertaking can be expected to experience some initial problems. WEJT is no exception. However, as the evaluation indicates, state and local agency staff have done a good job identifying and correcting problems as they turn up, and sharing what has been learned with other agencies. I believe that the first year's experience and the knowledge gained from this first evaluation has put Wisconsin in a good position to expand the WEJT program and to remain on the cutting edge of the welfare reform movement in the nation.

I must emphasize that this report is based on the first year of a long-term investment in AFDC recipients. Additional monitoring and evaluation of the program is necessary as it expands and matures. The Department will continue its evaluation efforts, and the Legislative Audit Bureau is currently conducting an evaluation of the program. In addition, 1987 Act 413 requires the Department to contract for a multi-year evaluation of WEJT to be completed by July 1, 1993. We shall continue to watch and learn as the WEJT program develops. But I must say that this initial evaluation report is promising. The WEJT program appears to be on track.
