To the Honorable the Legislature

We have completed a follow-up review of our 1987 management audit of the State Bureau of Procurement in the Department of Administration (#87-2) and found most of our recommendations have been adequately implemented. At your request, we included in our review an evaluation of the Department's use of life-cycle costing for the procurement of goods and services for

state consumption. Wisconsin Statutes require that lifecycle costing be used to make purchasing decisions 'whenever appropriate'.

Because life-cycle costing considers all the costs of ownership over the lifetime of an item rather than just purchase price, life-cycle costing offers the potential of cost savings over using a low bid method to make purchase decisions. While the best available data are not entirely conclusive, they do strongly suggest the life-cycle cost information the Department used to buy automobiles in FY 1984-85 is fairly accurate. Unfortunately, the limited number of these automobiles which have been sold and the lack of a control group of automobiles purchased using the traditional low bid method, prevents us from fully determining the savings the State may have achieved by using life-cycle costing for automobile purchases. We were able to determine, however, that savings between \$32,000 and \$45,000 each year have been achieved with life-cycle costing use for electronic typewriters, and approximately \$174,000 annually for photocopy machines.

Although the Department bought automobiles using life-cycle cost information purchased from a consulting firm from FY 1984-85 to FY 1986-87, the Department returned to using a low bid process in FY 1987-88 in response to questions about the formula's accuracy and its proprietary nature. While the best available information will never be entirely conclusive, we believe it provides sufficient support to urge the Department to use the life-cycle cost method in the future. We include options in the report for the Department to contract for the life-cycle cost information or develop such information in-house.

We also found that despite the demonstrated savings which have been achieved and the potential for even greater savings, the Department's use of life-cycle costing for the purchase of other commodities is limited. We suggest the Department more aggressively pursue expansion of life-cycle costing use. especially to commodities purchased this way in other states, such as office furniture, major appliances, and light bulbs and fixtures, and report to the Joint Audit Committee on the Department's progress by February 1, 1989.

We appreciate the courtesy and cooperation extended to us by the Department of Administration and other state agencies. A response from the Department is Appendix II.
