# State of Wisconsin Legislative Audit Bureau

September 7, 1988

To the Honorable the Legislature

At the direction of the Joint Legislative Audit Committee, we have completed a limited review of the Medicaid nursing home reimbursement formula which is administered by the Department of Health and Social Services. The formula is used to set reimbursement rates for nursing homes which care for residents who rely on the Medicaid program to finance at least a portion of their care.

The formula, as currently designed, has been effective in promoting cost containment through improved efficiency among nursing homes. The annual increase in nursing home rates has been less than the increase in inflation for three of the last four years. However, industry representatives are concerned that homes which are now operating efficiently may be unable to make further cost reductions which may be needed if future rate increases are limited.

There are a number of factors. including higher staffing standards and a trend toward older, more seriously ill residents which are likely to increase nursing home costs and require additional Medicaid expenditures. In addition, industry representatives are seeking modification to the formula which would increase the number of homes which are fully reimbursed. How the Legislature responds to these pressures for additional spending will depend, in part, on the Legislature's goals for cost containment and the amount of funding available.

We appreciate the courtesy and cooperation we received from the Department of Health and Social Services' staff and from the Wisconsin Association of Nursing Homes as well as others in the nursing home industry.
