In addition, I am attaching the Report of the Use of the 1987-88 Instructional Positions submitted in March, 1988 to the Joint Committee on Finance. That report provides a comprehensive evaluation of the use of the 100.5 positions received in 1987-88. It should be noted that in March, 1989, the UW System will provide a comprehensive report on the use of the 240.5 positions received in 1988-89. Teh March, 1989 reporting date was set by the Joint Committee on Finance in recognition that complete detailed discipline and section data on the allocation of the second year positions would not be available in October.

The 100.5 positions released in 1987-88 have allowed the UW System to begin making important instructional quality improvements and provide increased sections and class spaces high demand fields of study, The additional positions released in 1988-89 again have been targeted toward bottleneck and high demand areas of study and will add a significant number of new sections and additional class spaces.

The new positions and the implementation of our enrollment management plan have been extremely effective in reducing the scope of this problem. We are appreciative of your support of these initiatives and will provide you the March, 1989 summary report.
