To the Honorable the Senate:

I am pleased to submit the attached "Final Report on the Grandparent Liability Provisions of 1985 Wisconsin Act 56" and a separate summary of this report. This submission is being made pursuant to Section 41(2) of 1985 Wisconsin Act 56.

County departments of social services referred a total of 107 potential grandparent liability cases to district attorneys for pursuit of grandparent support between August 1986 and April 1988, and support was ordered in 13 cases. Just six of those cases involved paternal grandparents.

The low referral rate can be attributed to several factors, the most important of which is the lack of financial resources among grandparents. The age of minor fathers and mothers and the lengthy time required to establish paternity also contribute to the low referral rate.

Nearly two years after the law was passed, almost half of the parents and over 80% of teenagers had not heard about the law. This severly limits the potential impact of the law because a law cannot affect attitudes and behavior if people do not know about it. Among parents and teenagers who had heard about the law, there was a modest positive effect on family communication, attitudes and behavior.

The law does not appear to have led to a decline in the number of teen pregnancies. On the other hand, there is no evidence that the law led parents to pressure daughters to have abortions or to pressure sons to deny paternity.

I hope that this report will provide helpful information for any deliberations that the Legislature may have concerning this law.
