We have completed an audit of the financial statements fo the State Life Insurance Fund as required by s. 13.94, Wis. Stats. The audit covered the period January 1, 1986, through December 31, 1987. Our report contains the financial statements and related independent auditor's opinion for the years audited.

The State Life Insurance Fund is administered by the Office of the Commissioner fo Insurance. Created in 1911, it provides low cost life insurance policies to 29,000 Wisconsin residents. The insurance is available to individuals only and has a policy limit of \$10,000.

The Fund, which is self-funded through premiums and investment earnings. is a financially sound insurance program. The Office was able to declare extra policyholder dividends fo \$1.2 million in 1986 because of an excess surplus that accumulated as a result of previous, favorable experience. In 1987, the Fund realized a net gain from operations in excess of \$1 million, which increased the Fund's surplus to \$4.4 million as of December 31, 1987.

We appreciate the courtesy and cooperation extended to us by the staff of the Office fo the Commissioner of Insurance.

To the Honorable the Legislature

We have completed an evaluation of the Milwaukee County child support enforcement agency, as required by 1987 Wisconsin Act 27. In Milwaukee County, the Department of Child Support Enforcement is responsible for program administration, but the program is operated through a number of county departments, rather than a single. Therefore, we reviewed the system as a whole to determine whether it is operating to ensure maximum child support collections and prompt establishment of paternity.

We found that while the system has made some recent efforts to improve its effectiveness, a number of long-standing obstacles to effectiveness pervade the system. Among these are a lack of cooperation among some county departments. insufficient monitoring of child support enforcement efforts and of hearing schedules, and inadequate automation of a system which is responsible for monitoring in excess of 110,000 child support cases. These dificulties have caused lost collections potential and delays in case processing.

We paid particular attention to the issue of automation, since it has been a concern for many years and has been the source of heightened controversy in the past few months. The Department of Child Support Enforcement began this year to develop its own computer system because of dissatisfaction with the state Department of Health and Social Services' progress in developing a system for use in all the counties. In so doing, it has jeopardized the availability of federal funding for the statewide system, which is now being tested in two counties. Milwaukee County needs to work cooperatively with the Department of Health and Social Services to develop the elements the county needs to participate in the statewide system.

We appreciate the courtesy and cooperation we received from the Milwaukee County Department of Health and Social Services administrators and staff. Responses from Milwaukee County are Appendices II and III.
