Subject: **IMPACT STUDY -- RAISING THE MINIMUM DRINKING AGE FROM 19 TO 21**

The legislation that raised the minimum drinking age from 19 to 21 on September 1, 1986, also instructed the Wisconsin Department of Transportation to conduct four annual analyses of the law's impact and asked other state agencies to cooperate with the Department in conducting these studies. S. 85.07(6) required that the study include the impact on motor vehicle crash and fatality rates for young drivers and the impact on a variety of other alcohol and drug use indicators for young persons.

This is the fourth of four annual reports. It examines the impact on drinking driver crash rates and was prepared by the Department of Transportation. Previous reports in this series have included a second section, prepared by the Department of Health and Social Services, which examined other alcohol and drug use indicators required by the legislation. However, the major study necessary for that report is not yet available. Consequently, that section of this report will not be released until later in 1991.

To the Honorable the Legislature:

As required by 1989 Wisconsin Act 31, Section 3023(24z), I am submitting the enclosed report. Act 31 directed the Department of Health and Social Services to:

“Study methods of expanding the use in rural areas nonphysician health care providers, including nurse practitioners, physician assistants, registered nurses and licensed practical nurses. By January 1, 1991, the Department of Health and Social Services shall submit a report on the study to the chief clerk of each house of the legislature for distribution to the legislature in the manner provided in section 13.172(2) of the statutes.”

The purpose of the study was to determine the following:

- The feasibility of establishing a specialized training program for nonphysician providers to perform colposcopic examinations and follow-up activities for treatment of cervical cancer;
- The need for expanded colposcopy services in rural areas; and
- The feasibility for the delivery of expanded colposcopy services by nonphysician providers in rural areas.

The study that is described in the enclosed report indicates the following:

1. The feasibility of establishing a specialized training program for nonphysician providers was successfully demonstrated. The training project under study demonstrated success in establishing an approved course curriculum, obtaining qualified faculty, and recruiting interested and qualified nonphysician candidates with the necessary organizational and physician support to practice within their community.
2. The need for expanded colposcopy services that are accessible and affordable in rural areas was identified.
3. The feasibility of delivering expanded colposcopy services in rural areas by nonphysician providers was demonstrated.

The Department of Health and Social Services will continue to provide support for the expansion of colposcopy services as required by statute. Several

obstacles to the expansion of colposcopy services by nonphysician providers in rural areas have been mentioned in the report. The training project will continue to try to identify solutions to overcome these obstacles.

To the Honorable the Legislature:

We have completed our first biennial performance evaluation of the Wisconsin Lottery, as required by s. 13.94(1)(em), Wis. Stats. The Lottery has begun its third year of operation, and ticket sales continue to increase, from \$311.6 million in fiscal year 1989-90 to \$371.3 million estimated for fiscal year 1990-91.

The Wisconsin Constitution requires that net lottery proceeds be used for property tax relief, but little consensus exists on the best means to provide this relief. Approximately \$458.2 million is expected to be available for appropriation in the 1991-93 biennium, and devising a broadly-accepted means of providing property tax relief will be a major challenge facing the Legislature.

Our evaluation also includes information on two other issues of interest to the Legislature: the extent to which persons with low incomes participate in the lottery and the content and cost of the Lottery's advertising program.

Finally, based on comments of a number of current and former lottery staff, we believe lottery management faces an employee morale problem. Some causes of low morale may not be within management's control, but others appear to stem from a management style which some believe is intimidating and unresponsive to staff needs and concerns. We recommend lottery management devise a strategy for identifying and addressing the causes of low employee morale.

We appreciate the courtesy and cooperation extended to us by management and staff of the Wisconsin Lottery. The Lottery's response is the appendix.
