Pursuant to 1985 Wisconsin Act 296, I am today filing the Wisconsin Acid Research Council Biennial Report. This report, including the appendices, describes the activities of the Acid Deposition Research Council since the filing of the 1988 Biennial Report. The report contains all Research Council recommendations on acid deposition research and monitoring priorities, funding levels, and sources of funding discussed over the past two years.

The Wisconsin Acid Deposition Research Council was created by 1985 Wisconsin Act 296, and is attached to the Department of Administration. The Research Council was empanelled in May of 1986. Members of the Research Council represent industry, electric utilities,

environmental organizations, academia, and state government.

The Research Council believes the State of Wisconsin is leading the nation in both acid deposition policy and research and monitoring commitments. It is hoped that these recommendations will help maintain a cost-effective and valuable research and monitoring program.
