To the Honorable the Legislature:

We have completed a management review of the State of Wisconsin Investment Board. During fiscal year 1989-90, the Investment Board managed over \$23 billion of investments, such as stocks and fixed income securities.

We found that, while the Board has been able to exceed the investment returns assumed by the pension fund actuary, it has experienced an erosion of performance over the last several years compared to its own internallyestablished performance goals and to the returns earned by other large public investment funds. The principal reason for this erosion of performance is low returns on stock portfolios.

Since the implementation of a bonus compensation plan for board staff in 1988, the Board has awarded more than \$665,000 in bonuses. In each of the three years bonuses were awarded, more than 95 percent of eligible staff received a bonus. It appears, therefore, that bonuses have been used extensively as a salary supplement rather than as recognition for meritorious investment performance.

Approximately \$1.1 billion of investment funds have been invested in the Board's Invest in Wisconsin program, including \$325 million in loans to Wisconsin businesses. However, we also found that Wisconsin banks have shown little interest in the Board's Certificate of Deposit program. Only \$13.3 million of the \$200 million authorized by the Board were on deposit with Wisconsin banks at the end of fiscal year 1989-90.

We reviewed the ethical requirements and oversight mechanisms for board members and staff. We found no evidence that anything other than valid investment criteria have been used in making investment decisions. Overall, the Board has adopted necessary and adequate rules governing potential conflicts of interest, but we recommend that more be done to ensure that board members disclose their financial relationships to one another.

We appreciate the courtesy and cooperation extended to us by the staff of the Investment Board. The Executive Director's response is the appendix.
