Enclosed is an Order of the Department of Revenue Adopting An Emergency Rule relating to definitions of the terms "member of a reserve component" and "Desert Shield or Desert Storm theater of operations" as those terms are used in 1991 Wisconsin Act 2. A copy of this emergency rule is being sent to you pursuant to the requirements specified in s. 227.24(3), Stats. A certified copy of the order has been filed in the Office of the Secretary of State and the Office of the Revisor of Statutes as required by s. 227.20, Stats.

This emergency rule will become effective on April 29, 1991, after publication in the official state newspaper. It will remain in effect for 150 days after publication, when a permanent rule should be in place.
