PETITIONS AND COMMUNICATIONS State of Wisconsin Legislative Audit Bureau

May 7, 1991

To the Honorable the Legislature:

We have completed an evaluation of the State's primary programs designed to provide child care funds to low-and moderate-income families, as requested by the Joint Legislature Audit Committee. The Department of Health and Social Services administers these programs at the state level, while counties have local administrative responsibilities.

Our review confirms most of the concerns which prompted the audit. Many counties have encountered problems in effectively budgeting program funds, and the child care needs of many eligible families, particularly the working poor, have not been met. In addition, inconsistent program requirements have disrupted the continuity of services provided to families as they move between child care programs in their efforts to achieve economic self-sufficiency.

Several program changes have either been implemented or proposed to address these concerns since the audit was initiated. Most of these changes, especially the influx of additional federal funds, should increase the likelihood that the program objective of promoting selfsufficiency will be achieved. However, additional actions by the Department and counties will be needed to ensure that funds are allocated appropriately among counties and effectively budgeted.

In addition, the legislature will want to carefully review the potential effects of the Governor's proposal to require child care providers serving families in all state child care programs to be regulated. The proposal, while intended to eliminate inconsistent program requirements, may prompt a shortage of regulated child care in several areas of the state. We discuss options for legislative action on this issue.

We appreciate the courtesy and cooperation extended to us by department staff and staff of the several counties we visited. The Department's response is Appendix IV.
