We are pleased to submit the attached joint agency report on the Petroleum Storage Remedial Action Fund (PSRAF, commonly referred to as PECFA). This report was prepared cooperatively by staff of our two agencies as directed in the 1991-93 biennial budget recently signed into law by Governor Thompson.

This report contains recommendations designed to strengthen the fund's ability to facilitate environmental cleanups at sites contaminated by petroleum product releases. The agencies briefed the PECFA Council on the contents of the report September 27. A summary of Council's comments is included as an addendum to the report, and additional comments may be forthcoming.

Both of our Departments consider PECFA to be an indispensible tool for protecting public health and the environment in Wisconsin.
