On November 21, 1991, the Variable Retirement Fund (Fund 51) balance was \$-523 thousand. This shortfall continued until December 2nd when the Variable Retirement Fund balance reached \$ 2.3 million. The shortfall was due to an accounting allocation error, which has been corrected.

The Variable Retirement Fund shortfall was <u>not</u> in excess of the \$400 million ceiling and <u>did not</u> exceed the balances of the funds available for interfund borrowing.

The distribution of interest earnings to investment pool participants is based on the average daily balance in the pool and each fund's share. Therefore, the monthly calculation by State Finance will automatically reflect the use of these temporary reallocations of balance authority.
