To the Honorable the Legislature:

We have completed an evaluation of the meat inspection program of the Department of Agriculture, Trade and Consumer Protection, as requested by the Joint Legislative Audit Committee. The Department inspects meat processors not engaged interstate commerce to ensure the wholesomeness of meat products offered for sale to the public.

If the State were to eliminate its meat inspection program, the United States Department of Agriculture would assume responsibility for licensing and inspecting processors. However, it is likely that some smaller processors would be unable to meet all federal facility requirements without incurring unreasonable costs.

Overall, we found no evidence to conclude that meat products produced in Wisconsin are not generally safe and wholesome. Serious processing problems appear to exist in only a small number of processing plants. In general, inspectors appear to identify deficiencies promptly and usually gain the cooperation of processors in correcting deficiencies immediately. However, in cases when immediate compliance is not forthcoming, the Department needs to clarify enforcement policy and take other steps to ensure timely and uniform enforcement of inspection standards. Some processors with serious problems have continued to operate without making needed improvements.

The meat inspection requires that staff develop technical expertise and informed judgment in applying inspection standards. Staff training efforts have been inadequate in recent years to teach these skills, but additional funding made available in fiscal year 1991-92 and a new staff training plan are expected to improve training over the next year.

We appreciate the courtesy and cooperation extended to us by the staff of the Department of Agriculture, Trade and Consumer Protection and members of the Wisconsin Association of Meat Processors. A response from the Department is the appendix.

To the Honorable the Legislature:

This report is transmitted as required by ss. 20.002(11)(f) of the Wisconsin Statutes, (for distribution to the appropriate standing committees under section 13.172(3) stats.), and confirms that the Department of Administration has found it necessary to exercise the "temporary reallocation of balances" authority provided by this section in order to meet payment responsibilities and cover resulting negative balances during the month of February, 1992.

On February 5, 1992, the Recycling Fund (Fund 79) balance was \$-4.2 million. This shortfall continued through February 28, 1992 when the balance was \$-4.0 million. The shortfall is due to the timing of revenues to the fund.

The Recycling Fund shortfall was not in excess of the \$400 million ceiling and did not exceed the balances of the funds available for interfund borrowing.

The distribution of interest earnings to investment pool participants is based on the average daily balance in the pool and each fund's share. Therefore, the monthly calculation by State Finance will automatically reflect the use of these temporary reallocations of balance authority.
