Pursuant to Chapter 231.35(8) of Wisconsin Statutes, the Wisconsin Health and Educational Facilities Authority submits the following report:

The Rural Hospital Loan Guarantee Program is now operational. An informational package including an application for the program has been sent to qualified health care institutions. the Authority has also held two program briefings for those institutions to attend and obtain further information. To date, no applications for the program have been filed with the Authority. No loans have been guaranteed under this program. The annual gross revenues of borrowers who have received guarantees is zero. The default rate on such loans is also zero.

The Rural Hospital Loan Guarantee Fund has been funded with \$500,000 of state appropriations and currently has a fund balance of \$518,163.18.

The Wisconsin Health and Educational Facilities Authority will continue to administer the Rural Hospital Loan Guarantee Program and work with eligible borrowers as applications are submitted.

1987 Act 413 (s. 46.03(38)) requires the Department of Health and Social Services to provide a report to the Legislature by July 1, 1993 on its Work Experience and Job Training (WEJT) and Community Work Experience (CWEP) Program study. The attached report is being submitted to fulfill that requirement.

The report summarizes the history of the WEJT/ CWEP programs and their replacement by the Federal Job Opportunities and Basic Skills Training (JOBS) program in 1989. In addition, it summarizes the findings of past and current studies of Wisconsin's WEJT/CWEP program. Finally, it indicates the Department's intent to refocus its evaluation efforts from the WEJT/CWEP programs to the new JOBS program, resulting in a savings of state and federal funds.
