The 1991-93 budget bill (Act 483) contained the transfer of the First Capitol State Park at Belmont from the Department of Natural Resources to the State Historical Society on July 1, 1993. Language in the bill asks that the Department of Natural Resources and the State Historical Society submit a report defining a plan for the transfer along with the necessary funding for the site by July 1, 1992. The act also requires the identification of sources for funding. The two agencies are currently working on this report, but, for several reasons, I do not expect to submit it until September.

The Society filled the position of the Administrator for the Division of Historic Sites position last year. Since then, the Administrator has needed to focus attention on the funding crisis facing the sites, recruit site directors for Old World Wisconsin and Madeline Island Historical Museum, complex recruitments only completed several months ago. The Administrator has been coordinating the Society's involvement with the Legislative Audit Bureau relating to their nearly year-long audit of his program and discussing the responses to their report's recommendations.
