



**ASSEMBLY AMENDMENT 41,
TO ASSEMBLY SUBSTITUTE AMENDMENT 1,
TO 1995 ASSEMBLY BILL 150**

June 22, 1995 – Offered by Representatives RUTKOWSKI, LA FAVE and WASSERMAN.

1 At the locations indicated, amend the substitute amendment as follows:

2 **1.** Page 207, line 9: on lines 9 and 10, delete “and general equalization aids”.

3 **2.** Page 368, line 1: delete lines 1 to 6 and substitute:

4 “20.255 (2) (bm) (title) *Minimum state aid and general equalization aids*. The
5 amounts in the schedule for minimum state aid under s. 121.10 ~~and educational aids~~
6 ~~under s. 121.08. The amount distributed from this appropriation for educational aids~~
7 ~~under s. 121.08 in any fiscal year shall equal the total amount of aid reductions under~~
8 ~~s. 121.10 (6) in that fiscal year. No moneys may be encumbered under this paragraph~~
9 ~~after June 30, 1996.”.~~

10 **3.** Page 1397, line 2: after that line insert:

11 “SECTION 4055m. 121.07 (7) (a) of the statutes is amended to read:

12 121.07 (7) (a) The “primary guaranteed valuation per member” is an amount,
13 rounded to the next lowest dollar, that, after subtraction of payments under ss.
14 121.09, ~~121.10~~, 121.105 and 121.85 (6) (b) 2. and 3. and (c), fully distributes the sum

1 of the amount remaining in the appropriation under s. 20.255 (2) (ac) for payments
2 under ss. 121.08 and 121.85 (6) (a) and (g) and the amount remaining in the
3 appropriation under s. 20.255 (2) (bm) for payments under s. 121.08 as a result of the
4 aid reductions under s. 121.10 (6).”.

5 **4. Page 1397, line 3:** after “statutes” insert “, as affected by 1995 Wisconsin Act
.... (this act),”.

6 **5. Page 1399, line 6:** after that line insert:

7 “SECTION 4068m. 121.10 (6) of the statutes is repealed.”.

8 **6. Page 1399, line 8:** after that line insert:

9 “SECTION 4070m. 121.105 (1) of the statutes is amended to read:

10 121.105 (1) In this section “state aid” means the sum of the payments provided
11 to a school district under this section and ss. 121.08, 121.10, excluding any aid
12 reduction under s. 121.10 (6), 121.85 and 121.86. In the 1993-94 school year, “state
13 aid” includes the payment provided to a school district under s. 16.40 (20), 1991
14 stats.”.
