



**SENATE AMENDMENT 10,  
TO 1995 SENATE BILL 144**

September 27, 1995 - Offered by Senator ZIEN.

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 8, line 8: after that line insert:

3 “(am) When a respondent surrenders a firearm under par. (a) 2. to a sheriff, the  
4 sheriff who is receiving the firearm shall prepare a receipt for each firearm  
5 surrendered to him or her. The receipt shall include the manufacturer, model and  
6 serial number of the firearm surrendered to the sheriff and shall be signed by the  
7 respondent and by the sheriff to whom the firearm is surrendered. The sheriff shall  
8 keep the original of a receipt prepared under this paragraph and shall provide an  
9 exact copy of the receipt to the respondent.”

10 **2.** Page 8, line 24: after that line insert:

11 “(d) If, during the period in which an injunction issued under sub. (4) is in effect,  
12 a respondent needs to sell property due to economic hardship, the judge or family  
13 court commissioner shall permit the respondent to have access to any firearm  
14 surrendered under par. (a) 2. for the purpose of showing the firearm to a prospective  
15 buyer. A respondent who is given access to a surrendered firearm under this  
16 paragraph shall be supervised during the time that he or she has such access by the

1 sheriff to whom the firearm was surrendered under par. (a) 2. or, if the firearm was  
2 surrendered to a person other than a sheriff, by the sheriff of the county of residence  
3 of the person to whom the firearm was surrendered. The respondent shall report to  
4 the judge or family court commissioner the sale of any firearm resulting from a  
5 respondent's access to the firearm under this paragraph. If a firearm that was  
6 surrendered to a sheriff is sold as a result of the respondent's access to the firearm  
7 under this paragraph, the sheriff shall record the sale on the receipt prepared under  
8 par. (am) for the firearm and the sheriff and respondent shall sign the receipt to  
9 acknowledge the sale of the firearm.”.

10 **3.** Page 9, line 22: after that line insert:

11 “(am) When a respondent surrenders a firearm under par. (a) 2. to a sheriff, the  
12 sheriff who is receiving the firearm shall prepare a receipt for each firearm  
13 surrendered to him or her. The receipt shall include the manufacturer, model and  
14 serial number of the firearm surrendered to the sheriff and shall be signed by the  
15 respondent and by the sheriff to whom the firearm is surrendered. The sheriff shall  
16 keep the original of a receipt prepared under this paragraph and shall provide an  
17 exact copy of the receipt to the respondent.”.

18 **4.** Page 10, line 14: after that line insert:

19 “(d) If, during the period in which an injunction issued under sub. (5) is in effect,  
20 a respondent needs to sell property due to economic hardship, the judge or court  
21 commissioner shall permit the respondent to have access to any firearm surrendered  
22 under par. (a) 2. for the purpose of showing the firearm to a prospective buyer. A  
23 respondent who is given access to a surrendered firearm under this paragraph shall  
24 be supervised during the time that he or she has such access by the sheriff to whom

1 the firearm was surrendered under par. (a) 2. or, if the firearm was surrendered to  
2 a person other than a sheriff, by the sheriff of the county of residence of the person  
3 to whom the firearm was surrendered. The respondent shall report to the judge or  
4 court commissioner the sale of any firearm resulting from a respondent's access to  
5 the firearm under this paragraph. If a firearm that was surrendered to a sheriff is  
6 sold as a result of the respondent's access to the firearm under this paragraph, the  
7 sheriff shall record the sale on the receipt prepared under par. (am) for the firearm  
8 and the sheriff and respondent shall sign the receipt to acknowledge the sale of the  
9 firearm.”.

10 **5.** Page 11, line 8: after that line insert:

11 “(am) When a respondent surrenders a firearm under par. (a) 2. to a sheriff, the  
12 sheriff who is receiving the firearm shall prepare a receipt for each firearm  
13 surrendered to him or her. The receipt shall include the manufacturer, model and  
14 serial number of the firearm surrendered to the sheriff and shall be signed by the  
15 respondent and by the sheriff to whom the firearm is surrendered. The sheriff shall  
16 keep the original of a receipt prepared under this paragraph and shall provide an  
17 exact copy of the receipt to the respondent.”.

18 **6.** Page 11, line 24: after that line insert:

19 “(d) If, during the period in which an injunction issued under sub. (4) is in effect,  
20 a respondent needs to sell property due to economic hardship, the judge or court  
21 commissioner shall permit the respondent to have access to any firearm surrendered  
22 under par. (a) 2. for the purpose of showing the firearm to a prospective buyer. A  
23 respondent who is given access to a surrendered firearm under this paragraph shall  
24 be supervised during the time that he or she has such access by the sheriff to whom

1 the firearm was surrendered under par. (a) 2. or, if the firearm was surrendered to  
2 a person other than a sheriff, by the sheriff of the county of residence of the person  
3 to whom the firearm was surrendered. The respondent shall report to the judge or  
4 court commissioner the sale of any firearm resulting from a respondent's access to  
5 the firearm under this paragraph. If a firearm that was surrendered to a sheriff is  
6 sold as a result of the respondent's access to the firearm under this paragraph, the  
7 sheriff shall record the sale on the receipt prepared under par. (am) for the firearm  
8 and the sheriff and respondent shall sign the receipt to acknowledge the sale of the  
9 firearm.”.
