
Dear Representative Prosser:

In compliance with s. 227.19 (2), Stats., the Department of Development hereby submits the final draft of the proposed rule (CR-95- 123) relating to the Recycling Rebate and recycling Loan and Grant Program.

1995 Wisconsin Act 27 and 1993 Wisconsin Act 75 together removed administrative responsibility for awarding recycling rebates and recycling loans and grants from the Department of Development. Chapter DOD 23 contains the procedures and standards for the selection of recycling rebate and recycling loan and grant recipients. The proposed order repeals Chapter DOD 23 relating to the award of recycling rebates and recycling loans and grants in order to conform to the statutory changes. The Department held a hearing on the proposed rule on August 31, 1995 in Madison. No one appeared or commented on the proposed rule. The Legislative Council Clearinghouse report did not recommend any changes.
