**ASSEMBLY AMENDMENT 1,
TO SENATE AMENDMENT 1,
TO 1997 ASSEMBLY BILL 864**

April 28, 1998 – Offered by Representative SCHNEIDER.

1 At the locations indicated, amend the amendment as follows:

2 **1.** Page 1, line 6: after that line insert:

3 “3m. Page 54, line 14: before that line insert:

4 “**SECTION 156g.** 29.09 (11m) (a) (intro.) of the statutes, as created by 1997
5 Wisconsin Act (1997 Senate Bill 494), is repealed and recreated to read:

6 29.09 (**11m**) (a) *Approvals covered.* (intro.) This subsection applies to an
7 individual who is applying for, or applying to renew, any of the following approvals:

8 **SECTION 156m.** 29.09 (11m) (c) and (d) 2. of the statutes, as created by 1997
9 Wisconsin Act (1997 Senate Bill 494), is repealed.”.

10 4m. Page 86, line 9: delete “and (5)” and substitute “, (5) and (5m) (c)”.

11 5m. Page 86, line 24: after that line insert:

1 “(5m) (c) The band is requested to enact tribal laws or ordinances that deny an
2 application to issue or renew, suspend if already issued or otherwise withhold or
3 restrict an approval issued under this section if the applicant for or the holder of the
4 approval fails to provide the information required under tribal laws or ordinances
5 enacted under par. (b) or fails to comply, after appropriate notice, with a subpoena
6 or warrant issued by the department of workforce development or a county child
7 support agency under s. 59.53 (5) and related to paternity or child support
8 proceedings or if the department of workforce development certifies that the
9 applicant for or the holder of the approval has failed to pay court-ordered payments
10 of child or family support, maintenance, birth expenses, medical expenses or other
11 expenses related to the support of a child or former spouse.”.

12 6m. Page 87, line 1: before that line insert:

13 “**SECTION 308m.** 29.138 (5m) (b) of the statutes, as created by 1997 Wisconsin
14 Act (1997 Senate Bill 494), is repealed.”.

15 7m. Page 234, line 7: after that line insert:

16 “**SECTION 780m.** 1997 Wisconsin Act (1997 Senate Bill 494), section 9336 (1)
17 and (2) of the statutes are amended to read:

18 [1997 Wisconsin Act (1997 Senate Bill 494)] Section 9336 (1) APPROVAL
19 DENIALS FOR SUPPORT DELINQUENCY. The treatment of sections 29.09 (11m), 29.1085
20 (3) (c) 1. and 2., 29.134 (3), 29.135 (3), 29.145 (1c) (intro.), 29.33 (2) (d), 29.521 (2) (a)
21 and (c) 1., 29.544 (3), 29.574 (3), 29.575 (3) and 29.578 (4), (5) and (14) (am) and (b)
22 (intro.) of the statutes (~~with respect to information required on applications and with~~
23 ~~respect to denial of applications)~~ first applies to applications for issuing or renewing
24 approvals that are received on the effective date of this subsection and (with respect
25 to denial of or refusal to renew an approval for failure to comply with a subpoena or

1 warrant) first applies to failures to comply with subpoenas or warrants that are
2 issued on the effective date of this subsection.

3 (2) LICENSE DENIAL FOR FAILURE TO PAY SUPPORT. The treatment of sections 281.48
4 (3) (a) and (5) (b) and 299.08 of the statutes (~~with respect to information required on~~
5 ~~applications~~ and with respect to the denial of applications) first applies to
6 applications for initial or renewal licenses, registrations or certifications that are
7 received on the effective date of this subsection and (with respect to denial of or
8 refusal to renew a license, registration or certification for failure to comply with a
9 subpoena or warrant) first applies to failures to comply with subpoenas or warrants
10 that are issued on the effective date of this subsection.”.”.
