**Testimony on Assembly Bill 343
Assembly Committee on Environment
Representative Clifford Otte
June 4, 1997**

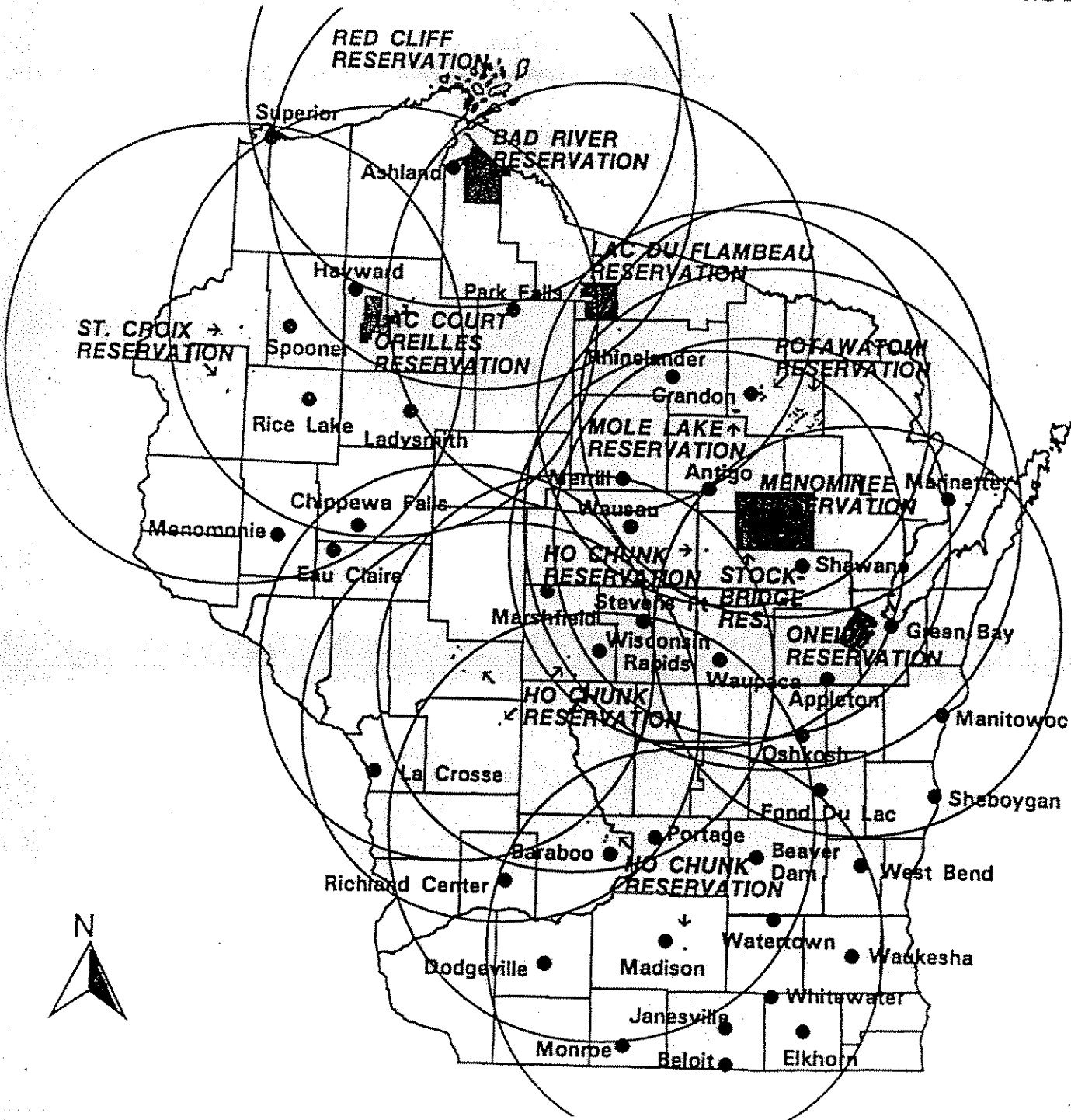
Mr. Chairman, thank you for holding a hearing on Assembly Bill 343. This bill and its companion, Senate Bill 194, were introduced after Senator Potter was contacted by a constituent whose mother received a notice for emissions testing after his father passed away and ownership of the vehicle transferred to his mother.

Under current law, the emissions inspections requirements include a requirement that any motor vehicle more than 5 model years old that is subject to an emissions inspection and whose ownership is transferred must undergo such an inspection within 45 days after the transfer of ownership, unless the vehicle passed such an inspection within 90 days prior to the transfer of ownership. AB 343 creates an exemption for that requirement when the transfer is to a surviving spouse.

I understand that it has been D.O.T. policy to waive the testing requirement when such spousal transfers occur. This bill will make that policy law. I think that everyone would agree that to do otherwise places an unnecessary burden on surviving spouses who are already burdened with grief and many other matters that they must attend to after the death of their spouse.
