12 technicians to provide emergency medical technical services in the municipality.

13 (ap) “Fire fighter” means a fire fighter employed by a municipality and a
14 volunteer fire fighter in a municipality that operates a volunteer fire department or
15 that contracts with a volunteer fire company organized under ch. 181 or 213.”.
