If the non-petitioning parent appears at the hearing on the petition or otherwise answers the petition and shows that he or she has not dissociated himself or herself from the minor or relinquished responsibility for the minor's care, support and well-being, the court shall require the consent of the nonpetitioning parent before changing the name of the minor. In the event that the child is or has been the subject of a CHIPS proceeding in which a final dispositional order has been entered with a CHIPS adjudication, and the nonpetitioning parent has neither custody nor placement, the court shall not require the consent of the nonpetitioning parent.
