TO 1999 ASSEMBLY BILL 699

1 At the locations indicated, amend the bill as follows:

2 1. Page 3, line 16: delete "sub. (4)," and substitute "subs. (3m) and (4)," ✓

3 2. Page 4, line 6: after that line insert:

4 "(3m) EXEMPTION OF PARDONED PERSONS FROM PROHIBITION. ✓ Subsection (2) ✓ does
5 not apply to any person who has received a pardon for the felony for which he or she
6 was convicted."

7 3. Page 4, line 7: delete "EXEMPTION." and substitute "REQUEST BY CERTAIN
8 PERSONS FOR COMPLETE OR PARTIAL EXEMPTION FROM PROHIBITION." ✓
