*↓ #. Page 1, line 2: after "concerning"
insert "certain".*

1 At the locations indicated, amend the bill as follows:

2 ↓ 1. Page 3, line 18: after "stop" insert "that is".

3 ↓ 2. Page 3, line 19: delete "agency:" and substitute "agency and that results in
4 the operator of or any passenger in the motor vehicle being arrested or given a
5 citation for a violation of any law or ordinance:".

6 ↓ 3. Page 4, line 15: delete lines 15 to 22 and substitute:

7 "(f) If the motor vehicle stop or a search conducted during the stop resulted in
8 the operator or any passenger being given a citation for a violation of any law or
9 ordinance, a listing of each citation given and the alleged violation for which the
10 citation was given.
