# Budget Amendments 1999- 2000

**Statement of Intent** UW System. Requires UW System to report Harassment and Discrimination Claims to the Legislature.

**Legislator** Goetsch

**Summary** The University of Wisconsin System is not required to report to the Legislature the disposition of harassment or discrimination claims against the UW.

This amendment would require the Office of the President of the University of Wisconsin System to biennially report to the Legislature, by September 1 of each even-numbered year, a summary concerning all of the employment harassment or discrimination claims filed against any UW campus or its employees if the claim was found to have merit. The report shall include the disposition of each complaint, a description of any discipline, correction, restitution or punishment enforced against the perpetrator and the amount of any money paid as settlement or court-ordered damages.

**Fiscal Impact** None. A report of this type is provided to the President currently. This amendment would require the President to provide a copy to the legislature.
