Motion #1120, relating to nonprofit conservation organizations (NCOs), was offered and deleted in committee.

Motion

This motion prohibits DNR from providing financial assistance or other support to nonprofit conservation organizations (NCOs) or to a federal agency for the purchase or a acquisition of interests when the project of the organization is more than 5,000 acres land unless one of the following occurs: (a) the majority of an elected body of a local unit of government where the project will take place approves DNR involvement; or (b) the Governor approves a DNR request for involvement. Require Governor to maintain a list of all requests submitted by DNR and whether the requests were approved or denied. Gubernatorial approval allowing the DNR to provide assistance or information shall not be construed as support of any project.
