### Summary

Under current law, the Department of Workforce Development determines the prevailing wage rates for all types of state and local public works projects and investigates alleged violations of the prevailing wage requirements. Each contractor and subcontractor that performs work on a project subject to the prevailing wage provisions is required to maintain payroll records. DWD and the contracting agency are authorized to obtain and examine those records. In addition, the Department is authorized to inspect the records at the request of any person. Once the Department or other public agency obtains the records they become public records.

A motion adopted by the Joint Committee on Finance will require all contractors and subcontractors that work on a project subject to the provisions of the state prevailing wage laws to maintain payroll records of covered employees and to allow the public to inspect these records under the state public records law.

This amendment repeals the Joint Finance action (motion #458).
