

**ASSEMBLY AMENDMENT 5,
TO ASSEMBLY SUBSTITUTE AMENDMENT 1,
TO 1999 ASSEMBLY BILL 133**

June 29, 1999 – Offered by Representatives STASKUNAS and LASSA.

5 in 1996 and ending in the year 2000 and \$10,201,000 in 2001 and thereafter.
