Delete Freestanding Motion 180, which guarantees that county Registers of Deeds do not charge for public use of their computers to search public records.

**FINANCIAL INSTITUTIONS**

**Uniform Commercial Code Record Search**

**Motion:**

Move to specify in the statutes that an individual may go to a county Register of Deeds office and search the records of the UCC Lien System free of charge. Require each Register of Deeds office to provide either a hard copy of such records or a computer terminal that would be available for an individual to use to perform a records search of the UCC Lien System. Require that the Department of Financial Institutions, at the request of a Register of Deeds office, provide the hard copy of the UCC Lien System data. Require the Department to keep all records that would be made available for public use as current as practicable.

---

**Note:**

This motion would require a Register of Deeds office to allow an individual to come into the office and search the UCC Lien System free of charge. However, a record search performed by a Register of Deeds office or by the Department of Financial Institutions at the request of an individual would continue to be subject to a \$10 fee per debtor name, as specified under current law.
