8 49.148 (1) (c) *Transitional placements.* For a participant in a transitional
9 placement, a grant of \$628, paid monthly by the Wisconsin works agency ~~or by the~~
10 ~~department under sub. (2),~~ except that the Wisconsin works agency shall make the
11 first grant payment not more than 14 days after the participant begins participating
12 under s. 49.147 (5). For every hour that the participant fails to participate in any

1 required activity without good cause, including any activity under s. 49.147 (5) (b)
2 1. a. to e., the grant amount shall be reduced by \$5.15. Good cause shall be
3 determined by the financial and employment planner in accordance with rules
4 promulgated by the department. Good cause shall include required court
5 appearances for a victim of domestic abuse.
