Impact Fees

Eliminate the Joint Finance Committee language as it relates to sewerage system service charges, impact fees and approval of plats.

The Joint Finance Committee acted to place further restrictions on local governments' abilities to recover **public facilities costs associated with development**. Motion 719 further narrows the list of public facility improvements for which developers can be assessed and dramatically alters the manner in which sewerage system service charged are applied.

Monies collected from developers are used to help offset costs of development i.e. parks, libraries, fire stations, etc.
