Hi Kevin,

Bill Berry from our office informed me that Aaron from your staff had called to request information on CAP's Community Based Economic Development (CBED) needs. Thank you for your interest in this program and for recalling our meeting earlier this year where I mentioned CAP has a need for more CBED funds.

CBED funding helps CAP provide technical assistance to small businesses in our service area. Since 1990, CAP Services has assisted 96 new low-income-owned businesses and created 279 new living-wage jobs. CBED funds are essential to the delivery of quality, one-on-one technical assistance to low-income entrepreneurs not available from other sources.

CAP's CBED funds were cut almost in half in 1999, to \$12,500. We are requesting that \$25,000 in each of the next two years be provided to CAP so that we can continue to build upon the successes of this program in creating living-wage jobs for people who really need them. In the interest of fairness to those who are doing similar work, we would ask that any appropriation specifically for CAP not come at the expense of other community action agencies in Wisconsin.

CBED funds are used to provide one-on-one pre- and post-technical assistance to low-income entrepreneurs in CAP's service area. Specifically, the funds help pay for staff time to operate our Self-Employment Program and Business Mentoring Program.

CBED funds are important for another reason: They generate matching funds. In fact, each CBED dollar is matched better than 2:1, very often by funds from the private sector. CBED money is the seed that helps us grow these other dollars.

Kevin, we really appreciate your interest in this need. It's also nice to know that while sitting on the Joint Finance Committee in the midst of a busy budget session, you took the time to seek this information.
