Independent Living Centers

Motion:

Move to provide \$500,000 GPR annually to increase funding for independent living centers.

Note:

DHFS is currently budgeted \$1,221,000 GPR annually to support independent living centers across the state. In addition, independent living centers are supported with federal funds available from the Social Security Administration (\$534,000 FED annually) and through the DWD Division of Vocational Rehabilitation (\$300,000 FED annually).

An independent living center is a community-based, non-residential center that provides an array of independent living services, including information and referral services, independent living skills training, peer counseling and individual and systems advocacy. There are currently eight independent living centers in Wisconsin.

This motion would increase funding for these centers by \$500,000 GPR annually.
