Proposed Budget Amendment**

Motion: Modify Assembly Substitute Amendment 1 to Assembly Bill 133 to clarify that only wage, fringe benefit and staffing increases provided by nursing homes after June 30, 1999 can be used for purposes of calculating the 5 percent wage pass through for eligible employees.

Under the motion adopted by the Joint Committee on Finance, retroactive wage, benefit or staffing increases as far back as July 1, 1998 could be offset by the 5 percent wage pass-through supplement. The Intent of the this motion is to clarify that the wage pass-through is to supplement only prospective costs, not increases already provided.

Motion: Modify the substitute amendment to direct the DHFS to prepare a supplemental application that nursing facilities which choose to utilize the wage pass-through supplement would be required to complete to determine if the nursing facility increased wages, benefits or staffing for eligible employees between July 1, 1999 and June 30, 2000 by an amount equal to or greater than the 5 percent wage pass through supplement.

Because facilities have different cost report periods, the use of a supplemental application is needed to provide the DHFS with the cost information necessary to ensure the wage pass-through will only apply to increased wages, benefits or staffing for eligible employees after June 30, 1999.
