(am), the total of amounts, as municipality. 14 depreciated, from the accounts of all public utilities for the same production plant is 15 also limited to not more than \$125,000,000. (ag)</u>, annually, the department 4 of administration, upon certification by the department of revenue, shall distribute 5 from the shared revenue account to any county having within its boundaries a 6 production plant or a general structure, including production plants and general 7 structures under construction, used by a light, heat or power company assessed 8 under s. 76.28 (2), except property described in s. 66.069 (2) unless the production 9 plant is owned or operated by a local governmental unit that is located outside of the 10 municipality in which the production plant is located, or by an electric cooperative 11 assessed under ss. 76.07 and 76.48, respectively, or by a municipal electric company 12 under s. 66.073 an amount determined by multiplying by 6 mills in the case of 13 property in a town and by 3 mills in the case of property in a city or village the first 14 \$125,000,000 of the amount shown in the account, plus leased property, of each 15 public utility except qualified wholesale electric companies, as defined in s. 76.28 (1) 16 (gm), on December 31 of the preceding year for either "production plant, exclusive 17 of land" and "general structures", or "work in progress" for production plants and 18 general structures under construction, in the case of light, heat and power 19 companies, electric cooperatives or municipal electric companies, for all property 20 within the municipality in accordance with the system of accounts established by the 21 public service commission or rural electrification administration, less depreciation 22 thereon as determined by the department of revenue and less the value of treatment 23 plant and pollution abatement equipment, as defined under s. 70.11 (21) (a), as 24 determined by the department of revenue plus an amount from the shared revenue 25 account determined by multiplying by 6 mills in the case of property in a town, and 1999 – 2000 Legislature – 4 –
