Technical and FYI Comments on Assembly Budget

Technical

1. Single Factor Sales – public utility provisions. References to public utilities were included in the bill @ s.71.04(8)(b), but also need to be included in another part of chapter 71. This change is needed to include utilities in single factor.

Delete the changes to sec. 71.25(10)(b) [see Page 253, line 21, through page 254, line 10, of AA 2 to ASA 1 to AB 133] and (c) and insert the same language that is found in AA 30 to AA 2 to ASA 1 to AB 133, page 8, lines 23 and 24 and page 9, lines 1-9.

2. IRC Update. The bill should include a nonstatutory provision relating to adopting the federal law changes for years prior to those still included in the statutes. See DOR's draft LRB 2926/2. This provision should read as follows:

ADOPTION OF FEDERAL INCOME TAX LAW CHANGES: Changes to the Internal Revenue Code made by Public Laws 105-178, 105-208 and 105-277 apply to the definitions of "Internal Revenue Code" in chapter 71 of the statutes, as affected by this act, at the time that the changes apply for federal income tax purposes.

3. Individual Income Tax – miscellaneous itemized deductions. The draft does not include an effective date for the provision specifying that the amount claimed as a federal miscellaneous deduction for repayment of income that was taxed in a prior year may be subtracted from federal adjusted gross income. This change was adopted by the Joint Finance Committee. The effective date should be taxable years beginning January 1, 2000 [see s.71.05(6)(b)29].

FYI Only

4. Education Tax Credit. The current provision is to create an individual and corporate income tax credit equal to 50% of the amount paid for an individual to participate in a college education program. A potential problem with this provision is that the draft does not require that the tuition have any connection to the business. The tuition would not have to be paid on behalf of someone who is employed in the business, but could simply be for the child or spouse of the business owner. If the intent of the provision is to encourage small business owners to offer educational opportunities to their employees, a change to the draft may be warranted.

It also appears that anyone who is a partner of a partnership, a member of an LLC, or a shareholder of a tax-option corporation would be able to claim this credit for any tuition they personally pay. Again, the tuition claimed for the credit could simply be that paid for a child or spouse of such individuals.

The initial applicability provision for this credits indicates it is to first apply to taxable years beginning on July 1, 2001. That means that for taxable year 2001, the credit will only be available to some fiscal years filers (those with a fiscal year start on or after July 1, 2001). The credit will not be available for taxable year 2001 to calendar year filers (about 99% of individual filers). It might be preferable to have the credit begin with taxable years beginning on January 1, 2002.
