2 **1.** Page 105, line 2: increase the dollar amount for fiscal year 1999-00 by  
3 \$750,000 and increase the dollar amount for fiscal year 2000-01 by \$750,000 to  
4 increase funding for the purposes for which the appropriation is made.

5 **2.** Page 1507, line 12: after that line insert:

6 **(7b)** LOAN TO CITY BREWERY.

7 (a) Notwithstanding section 560.61 (intro.) of the statutes and section 560.66  
8 (1) (intro.) of the statutes, as affected by this act, regardless of whether the  
9 development finance board so requests, the department of commerce shall make a  
10 loan of \$1,500,000 under section 560.66 of the statutes from the appropriations  
11 under section 20.143 (1) (c) and (ie) of the statutes, as affected by this act, to City  
12 Brewery in the city of LaCrosse if all of the following apply:

1           1. The proposed recipient submits a plan to the department of commerce  
2 detailing the proposed use of the loan and the secretary of commerce approves the  
3 plan.

4           2. The proposed recipient enters into a written agreement with the department  
5 of commerce that specifies the loan terms and the conditions for use of the loan  
6 proceeds, including reporting and auditing requirements.


7           3. The proposed recipient agrees in writing to submit to the department of  
8 commerce, within 6 months after spending the full amount of the loan, a report  
9 detailing how the loan proceeds were used.

10           (b) The department of commerce shall deposit in the appropriation account  
11 under section 20.143 (1) (ie) of the statutes, as affected by this act, any moneys  
12 received in repayment of the loan.

13           (c) The department of commerce may not pay loan proceeds under this  
14 subsection after June 30, 2001."
