Mobile Home Regulation Modifications

Motion:

Move to make the following changes related to the transfer of mobile home regulatory programs from the Departments of Administration and Transportation to the Department of Commerce:

1. Effective July 1, 2000, transfer 1.0 PR position in the DOA Division of Housing to Commerce, along with the DOA incumbent. In 2000-01, delete \$45,500 PR in DOA and provide \$45,500 PR in Commerce. In addition, repeal the DOA program revenue mobile home appropriation on June 30, 2000, and transfer the unencumbered appropriation balance to the Commerce Safety and Buildings operations program revenue appropriation.

2. Effective July 1, 2000, exempt the following from vehicle registration: (a) mobile homes, defined as a vehicle manufactured or assembled before June 15, 1976, designed to be towed as a single unit or in sections upon a highway by a motor vehicle and equipped and used, or intended to be used, primarily for human habitation, with walls of rigid uncollapsible construction, which has an overall length in excess of 45 feet; and (b) manufactured homes, defined to mean either of the following: (1) a structure, transportable in one or more sections, which in the traveling mode is eight body feet or more in width or 40 body feet or more in length, or, when erected on site is 320 or more square feet, and which is built on a permanent chassis and designed to be used as a dwelling with or without a permanent foundation when connected to the required utilities; or (2) a structure that meets the requirements under (1), except the size requirements, and with respect to which the manufacturer voluntarily files a certification required by the Secretary of the U.S. Department of Housing and Urban Development and complies with the standards established under 42 USC 5401 to 5425. Reduce estimated PR revenue collected by the Department of Commerce by \$24,300 in 2000-01.

Note:

On April 29, 1999, the Joint Committee on Finance approved Motion #208 to transfer mobile home regulatory programs from DOA and DOT to Commerce on July 1, 2000.

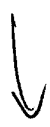
