2 with the child, including encouraging and facilitating frequent and continuing
3 contact with the child, or whether one party is likely to unreasonably interfere with
4 the child's continuing relationship with the other party.

18 placement under s. 767.24 may file a petition under sub. (3) if any of the following

20 (a) The parent has had one or more periods of physical placement denied by the
21 other parent.

22 (b) The parent has had one or more periods of physical placement substantially
23 interfered with by the other parent.

24 (c) The parent has incurred a financial loss or expenses as a result of the other
25 parent's intentional failure to exercise one or more periods of physical placement

1 under an order allocating specific times for the exercise of periods of physical

3 (3) PETITION. (a) The petition shall allege facts sufficient to show the following:

4 1. The name of the petitioner and that the petitioner has been awarded periods
5 of physical placement.

6 2. The name of the respondent.

7 3. That the criteria in sub. (2) apply.

8 (b) The petition shall request the imposition of a remedy or any combination
9 of remedies under sub. (5) (b) and (c). This paragraph does not prohibit a judge or
10 family court commissioner from imposing a remedy under sub. (5) (b) or (c) if the
11 remedy was not requested in the petition.

12 (c) A judge or family court commissioner shall accept any legible petition for
13 an order under this section.

14 (d) The petition shall be filed under the principal action under which the
15 periods of physical placement were awarded.

16 (e) A petition under this section is a motion for remedial sanction for purposes
17 of s. 785.03 (1) (a).

18 (4) SERVICE ON RESPONDENT; RESPONSE. Upon the filing of a petition under sub.
19 (3), the petitioner shall serve a copy of the petition upon the respondent by personal
20 service in the same manner as a summons is served under s. 801.11. The respondent
21 may respond to the petition either in writing before or at the hearing under sub. (5)
22 (a) or orally at that hearing.

23 (5) HEARING; REMEDIES. (a) A judge or family court commissioner shall hold a
24 hearing on the petition no later than 30 days after the petition has been served,
25 unless the time is extended by mutual agreement of the parties or upon the motion

1 of a guardian ad litem and the approval of the judge or family court commissioner.
2 The judge or family court commissioner may, on his or her own motion or the motion
3 of any party, order that a guardian ad litem be appointed for the child prior to the
4 hearing.

5 (b) If, at the conclusion of the hearing, the judge or family court commissioner
6 finds that the respondent has intentionally and unreasonably denied the petitioner
7 one or more periods of physical placement or that the respondent has intentionally
8 and unreasonably interfered with one or more of the petitioner's periods of physical
9 placement, the court or family court commissioner:

10 1. Shall do all of the following:

11 a. Issue an order granting additional periods of physical placement to replace
12 those denied or interfered with.

13 b. Award the petitioner a reasonable amount for the cost of maintaining an
14 action under this section and for attorney fees.

15 2. May do one or more of the following:

16 a. If the underlying order or judgment relating to periods of physical placement
17 does not provide for specific times for the exercise of periods of physical placement,
18 issue an order specifying the times for the exercise of periods of physical placement.

19 b. Find the respondent in contempt of court under ch. 785.

20 c. Grant an injunction ordering the respondent to strictly comply with the
21 judgment or order relating to the award of physical placement. In determining
22 whether to issue an injunction, the judge or family court commissioner shall consider
23 whether alternative remedies requested by the petitioner would be as effective in
24 obtaining compliance with the order or judgment relating to physical placement.

1 (c) If, at the conclusion of the hearing, the judge or family court commissioner
2 finds that the petitioner has incurred a financial loss or expenses as a result of the
3 respondent's failure, intentionally and unreasonably and without adequate notice to
4 the petitioner, to exercise one or more periods of physical placement under an order
5 allocating specific times for the exercise of periods of physical placement, the judge
6 or family court commissioner may issue an order requiring the respondent to pay to
7 the petitioner a sum of money sufficient to compensate the petitioner for the financial
8 loss or expenses.

9 (d) Except as provided in par. (b) 1. a. and 2. a., the judge or family court
10 commissioner may not modify an order of legal custody or physical placement in an
11 action under this section.

12 (e) An injunction issued under par. (b) 2. c. is effective according to its terms,
13 for the period of time that the petitioner requests, but not more than 2 years.

14 **(6) ENFORCEMENT ASSISTANCE.** (a) If an injunction is issued under sub. (5) (b)
15 2. c., upon request by the petitioner the judge or family court commissioner shall
16 order the sheriff to assist the petitioner in executing or serving the injunction.

17 (b) Within 24 hours after a request by the petitioner, the clerk of the circuit
18 court shall send a copy of an injunction issued under sub. (5) (b) 2. c. to the sheriff
19 or to any other local law enforcement agency that is the central repository for orders
