PURPOSE:

Reach agreement on language revisions to Senate Bill 90 proposed by the EMS Section

1. Medical Director definition – The current language calls for a physician to serve as medical director **for the courses being taught**. A medical director is defined in this section as “a physician who trains, medically coordinates, directs, supervises, establishes standard operating procedures for, and designates physicians for direction and supervision of, emergency medical technicians and who reviews the performance of emergency medical technicians and ambulance service providers.

The suggested revision is to require a “medical advisor” who is defined as “A physician, or their designee, who oversees medical **issues related to the site and personnel where the defibrillator is located. The medical advisor shall be the primary contact for any medical questions or issues related to the training or performance of persons trained to provide defibrillation.**”

The person who houses the defibrillator would also have to give the name of the medical advisor to the nearest emergency medical services program.

2. Continuing Education – Add requirement that person “receives continuing education at least every two years.”
3. Training Course – Has to have specific qualifications for instructors.
