This bill changes the boundaries of Jackson County and Monroe County to reflect what county officials understand to be the boundaries of these two counties.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

3             **SECTION 1.** 2.01 (27) of the statutes is amended to read:

4             2.01 (27) JACKSON: Beginning at the southeast corner of township 20, of range  
5             one east of the meridian aforesaid; running thence north on the range line to the  
6             township line between townships 22 and 23; thence west on said township line to the  
7             southwest corner of township 23, of range 3 west; thence north on the range line to  
8             the northwest corner of said township 23, of range 3 west; thence west on the

1 township line to the range line between ranges 4 and 5 west; thence north on said  
2 range line to the township line between townships 24 and 25; thence west on said  
3 township line to the range line between ranges 6 and 7 west; thence south on said

5 township line to the southwest corner of section 34, of township 19, of range 5 west;  
6 thence north on section lines to the point where the center of Black river crosses the  
7 west line of the southwest quarter of section 15, in said township and range; thence  
8 northeasterly, northerly and westerly along the center of Black river to the point  
9 where the center of said river crosses the east line of the northeast quarter of section  
10 16, in said township and range; thence north on section lines to the point where the  
11 center of said river crosses the west line of section 10, in said township and range;  
12 thence northeasterly in the center of said river to the point where the said center  
13 crosses the south line of section 2, in said township and range; thence east to the  
14 southeast corner of said section 2; thence north to the point where the center of said  
15 river crosses the east line of said section 2; thence northeasterly in the center of said  
16 river to the point where said center crosses the east line of section one, in said  
17 township and range; thence north to the northeast corner of said section one; the west  
18 lines of sections 34, 27, 22 and 15 of township 19 north, range 5 west, to the most  
19 southerly intersection with the centerline of the Black River; thence in a  
20 northeasterly direction along said centerline of the Black River to its intersection  
21 with the north line of section 6, township 19 north, range 4 west; thence east on the  
22 township line between townships 19 and 20 to the place of beginning.

23 **SECTION 2.** 2.01 (41) of the statutes is amended to read:

24 2.01 (41) MONROE: Beginning at the southeast corner of township 15, of range  
25 one east of the meridian aforesaid; running thence north on the range line to the

1 township line between townships 19 and 20; thence west on said township line to the  
2 northeast corner of section one, in township 19, of range 5 west; thence south to the  
3 point where the center of Black river crosses the east line of said section one; thence  
4 southwesterly in the center of said river to the east line of section 2, in said township  
5 and range; thence south to the southeast corner of said section 2; thence west to the  
6 point where the center of said river crosses the south line of said section 2; thence  
7 southwesterly in the center of said river to the point where said center crosses the  
8 east line of section 9, in said township and range; thence south on section lines to the  
9 point where the center of said river crosses the east line of the northeast quarter of  
10 section 16, in said township and range; thence easterly, southerly and southwesterly,  
11 in the center of said river, to the point where said center crosses the east line of the  
12 southeast quarter of said section 16; thence south on section lines to the southwest  
13 corner of section 34, in said township and range; thence east to the range line  
14 between ranges 4 and 5 west; centerline of the Black River where it intersects with  
15 the north line of section 6, township 19 north, range 4 west; thence in a southwesterly  
16 direction along said centerline of the Black River to its most southerly intersection  
17 with the west line of section 15, township 19 north, range 5 west; thence south on the  
18 west lines of sections 15, 22, 27 and 34 of township 19 north, range 5 west to the  
19 southwest corner of said section 34, being a point on the township line between  
20 townships 18 and 19; thence east on said township line to the range line between  
21 ranges 4 and 5 west; thence south on said range line to the township line between  
22 townships 14 and 15; thence east on said township line to the southwest corner of the  
23 southeast quarter of the southwest quarter of section 34, township 15, of range 2  
24 west; thence north to the northwest corner of said southeast quarter of the southwest  
25 quarter; thence east one mile to the northeast corner of the southwest quarter of the

1 southwest quarter of section 35, township 15, of range 2 west; thence south to the  
2 southeast corner of said southwest quarter of the southwest quarter; thence east on
