

**SENATE AMENDMENT 1,  
TO SENATE SUBSTITUTE AMENDMENT 1,  
TO 1999 SENATE BILL 378**

March 29, 2000 – Offered by Senator COWLES.

1 At the locations indicated, amend the substitute amendment as follows:

2 **1.** Page 1, line 2: delete “and granting rule-making authority” and substitute  
3 “, granting rule-making authority and making an appropriation”.

4 **2.** Page 1, line 3: delete the material beginning with that line and ending with  
5 page 2, line 3, and substitute:

6 “**SECTION 1m.** 20.143 (1) (c) of the statutes, as affected by 1999 Wisconsin Act  
7 9, is amended to read:

8 20.143 (1) (c) *Wisconsin development fund; grants, loans, reimbursements and*  
9 *assistance.* Biennially, the amounts in the schedule for grants under ss. 560.145,  
10 560.16, 560.175, 560.26; for grants and loans under ss. 560.62, 560.63 and 560.66;  
11 for loans under s. 560.147; for reimbursements under s. 560.167; for providing  
12 assistance under s. 560.06; for the costs specified in s. 560.607; for the loan under

1 1999 Wisconsin Act 9, section 9110 (4); for making payments under s. 93.75 of not  
2 more than \$3,000,000 in each fiscal year through fiscal year 2005–06; and for the  
3 grants under 1995 Wisconsin Act 27, section 9116 (7gg), 1995 Wisconsin Act 119,  
4 section 2 (1), 1997 Wisconsin Act 27, section 9110 (6g), and 1999 Wisconsin Act 9,  
5 section 9110 (5). Of the amounts in the schedule, \$50,000 shall be allocated in each  
6 of fiscal years 1997–98 and 1998–99 for providing the assistance under s. 560.06 (1).  
7 Notwithstanding s. 560.607, of the amounts in the schedule, \$125,000 shall be  
8 allocated in each of 4 consecutive fiscal years, beginning with fiscal year 1998–99,  
9 for grants and loans under s. 560.62 (1) (a).”.

10 **3.** Page 2, line 7: substitute “awards” for “payments”.

11 **4.** Page 2, line 16: delete “PAYMENTS. The department shall pay” and substitute  
12 “AWARDS. The department shall make an award to”.

13 **5.** Page 2, line 19: delete “payments” and substitute “awards”.

14 **6.** Page 2, line 20: delete “payments” and substitute “awards”.

15 **7.** Page 3, line 2: delete “payments” and substitute “awards”.

16 **8.** Page 3, line 3: before that line insert:

17 “**(3e)** PAYMENTS. At the request of the department of agriculture, trade and  
18 consumer protection, the department of commerce shall make a payment from the  
19 appropriation under s. 20.143 (1) (c) to a person equal to the amount of an award  
20 made under sub. (2).”.

21 **9.** Page 4, line 3: delete “a payment” and substitute “an award”.
