SA to 1999 SB-144

November 3, 1999 - Offered by Representative OWENS.

- 1 At the locations indicated, amend the bill as follows:
- 2 **1.** Page 1, line 4: after "grounds" insert ", granting rule-making authority". ✓
- 3 **2.** Page 2, line 1: delete lines 1 to 4. ✓
- 4 **3.** Page 2, line 4: after that line insert:
- 5 "SECTION 1m. 101.123 (1) (ar) of the statutes is created to read:
- 6 101.123 (1) (ar) "Immediate vicinity of the state capitol" means the area
- 7 directly adjacent to the state capitol building, as determined by rule of the
- 8 department of administration. "Immediate vicinity of the state capitol" does not
- 9 include any location that is more than 65 feet from the state capitol building". ✓
- 10 **4.** Page 2, line 7: delete "on the state capitol grounds" and substitute "in the
- 11 immediate vicinity of the state capitol". ✓
- 12 **5.** Page 2, line 11: delete "or on the state capitol grounds" and substitute "in
- 13 the immediate vicinity of the state capitol". ✓

1           **6.** Page 4, line 9: after that line insert:

2           “**SECTION 9m. Nonstatutory provisions.**

3           (1) SUBMISSION OF PROPOSED RULE DETERMINING THE IMMEDIATE VICINITY OF THE  
4 STATE CAPITOL. No later than the first day of the 3rd month beginning after  
5 publication, the department of administration shall submit in proposed form the rule  
6 determining the area that qualifies as the immediate vicinity of the state capitol  
7 under section 101.123 (1) (ar) of the statutes, as created by this act, to the legislative  
8 council staff under section 227.15 (1) of the statutes. The proposed rule shall include  
9 a diagram that illustrates the area that qualifies as the immediate vicinity of the  
10 state capitol.

11           **SECTION 10m. Effective dates.** This act takes effect on the first day of the 6th  
12 month beginning after publication, except as follows:

13           (1) SUBMISSION OF PROPOSED RULE DETERMINING THE IMMEDIATE VICINITY OF THE  
14 STATE CAPITOL. ~~The treatment of SECTION 9m (1) of this act takes effect on the day after~~  
15 publication.”. ✓
