1 AN ACT...; relating to: increasing funding for transportation facilities economic
2 assistance and development and making an appropriation.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

3 SECTION 1. Appropriation changes.

4 (1) TRANSPORTATION FACILITIES ECONOMIC ASSISTANCE AND DEVELOPMENT. In the
5 schedule under section 20.005 (3) of the statutes for the appropriation to the the
6 department of transportation under section 20.395 (2) (iq) of the statutes, as affected
7 by the acts of 1999, the dollar amount is increased by \$4,800,000 for fiscal year
8 2000-01 for the purpose of economic assistance and development.
