TO 1999 ASSEMBLY BILL 174

1 AN ACT ...; relating to: an exception for peace officers to prohibitions relating to  
2 the transportation of firearms in motor vehicles. ✓

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

3 SECTION 1. 167.31 (1) (em) <sup>X</sup> of the statutes is created to read:  
4 167.31 (1) (em) "Peace officer" has the meaning given in s. 939.22 (22). ✓

5 SECTION 2. 167.31 (4) (a) 1. <sup>X</sup> of the statutes is repealed.

6 SECTION 3. 167.31 (4) (am) <sup>X</sup> of the statutes is created to read:  
7 167.31 (4) (am) 1. Subsections (2) (a), (c) and (d) and (3) (a) and (b) <sup>✓</sup> do not apply  
8 to a peace officer who, in the line of duty, loads or discharges a firearm in, on or from  
9 a vehicle, motorboat or aircraft or discharges a firearm from or across a highway or  
10 within 50 feet of the center of a roadway.

11 2. Subsection (2) (b) <sup>✓</sup> does not apply to a peace officer who places, possesses or  
12 transports a firearm in or on a vehicle, motorboat or aircraft while in the line of duty.

1           3. Subsection (2) (b) <sup>✓</sup> does not apply to a person employed as a peace officer who  
2 places, possesses or transports a firearm in or on a vehicle while traveling in the  
3 vehicle from his or her residence to his or her place of employment as a peace officer.

4           **SECTION 4. Initial applicability.**

5           (1) This act first applies to the placement, possession or transportation of a  
6 firearm that occurs on the effective date of this subsection. <sup>✓</sup>
