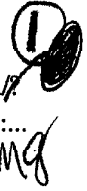

TO ASSEMBLY SUBSTITUTE AMENDMENT (LRBs0476/1),
TO 1999 ASSEMBLY BILL 892**

1 At the locations indicated, amend the substitute amendment as follows:

2 ✓ 1. Page 2, line 11: after "law" insert "prohibiting discrimination on the basis
3 of whether a contractor's employes are covered under a collective bargaining
4 agreement in contracting for the construction of professional football stadium
5 facilities;"

6 ✓ 2. Page ³⁵~~33~~, line ¹⁰~~20~~: after "district." insert "In contracting for the acquisition
7 and construction of football stadium facilities that are part of any facilities that are
8 leased by the district to a professional football team or to a related party, the district
9 board, team or related party may not discriminate against any contractor on the
10 basis of whether the contractor's employes are covered under a collective bargaining
11 agreement.".
