1 At the locations indicated, amend the substitute amendment as follows:

2 1. Page ³¹, line ⁴: after that line insert:

text: (re)

(17) (d) The district and a professional football team, as described in s. 229.823, enter into an agreement under which the team agrees that with regard to any national television contract between a television network and a league of professional football teams, as described in s. 229.823, that takes effect after the effective date of this paragraph *Y.K.* [revisor inserts date], any share from such a contract that is distributed to the team shall be forwarded to the district and shall be used by the district to retire bonds issued for purposes related to football stadium facilities, until such bonds, including bonds issued to fund or refund those bonds, are retired.”
