TO 1999 ASSEMBLY BILL 892**

March 24, 2000 – Offered by Representatives ZIEGELBAUER, CILLEN and KRUG.

1           At the locations indicated, amend the substitute amendment as follows:

2           **1.** Page 29, line 18: after “practicable.” insert “The explanatory statement  
3 included in the type C notice shall indicate that an affirmative vote on the first  
4 question will authorize the funding of debt service costs on bonds not exceeding  
5 \$160,000,000 in principal amount, exclusive of bonds issued for the purposes  
6 specified in s. 229.829 (4), the proceeds of which may be used for purposes related to  
7 football stadium facilities, including the maintenance, operating and administrative  
8 costs specified in s. 229.825 (2), and shall set forth in each instance the specific  
9 maximum dollar amounts and purposes for which the bond proceeds may be used.”.
